





Production MTCs annual production season is selected to ensure a balance of programming that can meet the needs of young people and families in our community, examining the educational, health, and social development of young people. As MTC serves classrooms as well as families, all productions are designed to integrate into school curriculum as well. The on-going COVID-19 pandemic directly impacted the delivery methods for MTC productions during 2020-2021 Season, but in adapting to virtual programming, MTC was able to expand its programs offerings and expand the reach of those offerings. EDUCATION A core component of MTCs community impact comes through education programs, delivered in most years directly into schools across the St. Louis region. Education is also integrated directly into all productions, with learning guides provided to schools and districts prior to attending live or virtual performances or field trips. These guides extend the experience of each production into grade level specific curriculum, enabling continued learning after attending a live performance. Local partner districts include St. Louis City, University City, Maplewood, Richmond Heights, Webster Groves, Ferguson-Florissant, Clayton, Normandy, Jennings, Brentwood, and a range of private and parochial schools. Through expanded reach from digital learning and virtual field trips, educational curriculum from MTC was incorporated during the 2020-21 Season also with schools in California, Illinois, Michigan, Texas, Washington, Wisconsin, Virginia and across many corners of Missouri. As such, several multi-year pledges (including gifts from the Berges Family Foundation and the Regional Arts Commission) were recorded in FY19 upon their receipt and do not appear as revenue in FY21, but rather as releases from restrictions. MTC gratefully received loans from the Paycheck Protection Program in both FY20 and FY21 as part of the federal relief programs available to small businesses. MTC met the terms of loan forgiveness for both PPP loans and both loans were forgiven in FY21. The generosity of the local philanthropic community, combined with these relief funds, enabled MTC to end the year with a necessary cash reserve, which was held in anticipation of expenses and the anticipated financial risks ahead in FY22 upon the resumption of indoor live theater. In FY21, only one of four productions was offered for live audiences and as such programmatic expenses were lower as compared to pre-pandemic years. MTC's commitment to retain staff without risk of furloughs or layoffs resulted in a higher ratio of management and general expenses, even with the company's two top paid executives taking voluntary salary reductions to maintain a healthy financial position. As a result of reduced live performances, contributed revenue became MTC's primary source of revenue throughout FY21, increasing fundraising costs. As a result MTC's ratio of program expenses to management, general, and fundraising expenses has reduced in FY21. With a full season of live performances in FY22, it is anticipated that that ratio will return to pre-pandemic levels.
